Art. 3 Exemption from the payment of fees

¹ The federal authorities and institutions and those of the cantons and municipalities may be exempted from payment of fees where they avail themselves directly of a service and maintain reciprocity.

² Fees are waived for journalists for services rendered for them relating to court reporting at the Federal Patent Court.

³ Fees may be waived for services for the benefit of non-profit institutions.

Art. 5 Surcharge

An express surcharge of up to 50 per cent may be imposed where the service is rendered on an urgent basis upon request.

Art. 6 Expenses

Expenses of the Court will be additionally invoiced, namely

Art. 9 Imposition of fees

The Chief Court Registrar imposes the fees and the expenses with the services rendered.
